Programme Overview

Description

The Government Health and Safety Lead (GHSL) has partnered with the Institute of Directors (IoD) to offer a new Officer Development Programme, designed for public service agency senior leaders with officer responsibilities under the Health and Safety at Work Act 2015 (HSWA).

Programme Components

This professional development programme includes 8.5 hours of in-person workshops (a customised IoD Advanced Health and Safety course, delivered across four short modules), supplemented by pre-and post-course e-learning modules, reading materials, resources, tools, and case studies.

All course and resource content has been tailored for the public service, recognising that officers in most central departments and agencies are also senior leaders with management responsibilities for health and safety.

Structured Course Component

Course Overview - Institute of Directors Advanced Health and Safety

Content from the IoD Directors' Advanced Health and Safety course has been tailored to meet the specific needs of the public service.

The following topics are covered across four, two-hour modules. Each topic will be explored with a governance focus but with consideration as to how the topic may be viewed through different lenses (governance, leadership, management) in a public sector environment:

- Managing, leading, and governing Health & Safety an overview of the three roles and perspectives. Includes leadership behaviours and practices. Recap on the scope of PCBU duties. Bringing it to life -practical application i.e. meeting structures, reporting, questions that should be asked, using the three lenses of governance, leadership, and management.
- Health and Safety risk management. Risk landscape (acute, chronic, and catastrophic), risk assessment methodologies, implementing effective prevention and mitigation controls, controls assurance (3 lines of defense), risk tolerance, owning your risk matrix, alignment with Enterprise Risk Management.
- Overlapping duties and understanding the complexity and challenges of identifying and managing them (particularly thinking about the public sector's wider role in policy setting, standard setting, system ownership/funding).
- Monitoring what matters setting meaningful KPIs, data, insights, reporting and information management systems this module references the Business Leaders' Health and Safety Forum guide "Monitoring What Matters".

We encourage you to take time after each workshop to reflect and apply your learning, for example:

- Identify one item you want to action or explore further in between each module.
- Engage with your Health and Safety Manager to discuss a health and safety issue in your agency or attend a health and safety committee meeting at one of your offices.
- Conduct a site visit within your own agency and follow through a critical risk.
- Engage with front line workers to get an unrefined view health and safety from the workers' perspective.

Engage in one on one coaching between modules. This could be via an existing arrangement, with a peer (from your agency or from within the Programme), or through external (structured) coaching.
