# Membership

It has been another strong year for the branch. We welcomed 31 new members into the branch and our membership at the end of 2020 stood at 186 (179 at end of 2019), a big increase since the start of the branch in May 2012 when we had 84 members. Our congratulations to Anita Scott and Brian Ropitini who were recognised as Chartered Members this year and to Bev Gibson who was recognised as a Chartered Fellow and we are delighted to present this at the 2020 AGM.

# **Branch Events**

In 2020 the branch ran 15 events, 8 of these were online. These events offered members a mix of local access to speakers from outside of the region, as well as a forum to discuss issues of local interest.

The Taranaki Committee initiated the very successful virtual coffee cart series of events in April and May to create an ongoing leadership conversation amongst our members and community leaders. 273 attended this series of complementary events (6 events)

Another highlight was our annual dinner in November. We were delighted to be able to come together for this event and had a full house who enjoyed listening to guest speaker to Rob Campbell. Rob reflected on his learnings as a director over 2020 and his resolutions and priorities for 2021. He also called on directors to be leaders in social and economic change.

A big thank you to all of you who support our branch events through your attendance and by bringing clients, colleagues and other guests. As always we are interested in your feedback on guest speakers and topics of interest.
