Chair's Report

The Branch Chair's report for 2024 was taken as read, having been circulated prior to the meeting. Rachel Farrant presented highlights on behalf of Suse Reynolds, including:

- The Chair extended a warm welcome to all Wellington Branch members and noted Wellington as the second-largest branch nationwide. Expressed gratitude for members' ongoing support and interest in governance. Highlighted the collective power of governance: "None of us are as clever as all of us together."
- **Branch committee role and aspirations.** The committee connects IoD to local member interests, focusing on: governance-related activities; educational opportunities; networking to grow members' effectiveness; encouraged members to share feedback and seek committee support for connections and resources.
- **2025 goals and strategy.** Commitment to continue to deliver a series of engaging, well-marketed events. Integration of the Top 5 themes: return on capital; governance reform; climate as a competitive edge; quantum leaps ahead; the high-performing chair.
- Plans to grow engagement by: sourcing quality speakers through committee networks; refining event formats to create welcoming, engaging experiences; injecting fresh energy; and leveraging senior directors' experience.
- Underpinning all activities with:
 - Deep empathy for people and the planet
 - Strong partnership and respect for te ao Māori
- **Committee and branch leadership:** acknowledged the hands-on role of the branch committee in supporting Branch Manager Jill Dawson and Branch Executive Holly Pears.
- Aim to deliver events that challenge, inspire, and inform members.
- Intention to provide more operational governance insights and practical "how to" sessions.
- **Acknowledgements:** the Chair expressed gratitude to the dedicated branch committee:

Anne Urlwin, Mike Devonshire, Nives Botica-Redmayne, Rachel Farrant, Jackie Lloyd, Brad Olsen, Pania Gray, Herman Visagie, Kenny Tsui, Garth Cowie, and Murray Sherwin.

- **Wellington branch update:** Membership update:
 - Year-end total: 2,255 members (below growth target of 1.55%)
 - Female members: 40.7% (up 1.7%)
 - Māori members: 12.2% (up 0.6%)
 - Event delivery: 36 events held in 2024 (target was 41) *Cancellations due to declining registrations, particularly in late 2024.*
- Highlighted event: Annual dinner featuring Brad Olsen, Sonya Williams (Sharesies), and Jessie Wong (Yu Mei), focusing on their business journeys and governance insights.
- **Distinguished Fellows:** congratulations to new Distinguished Fellows: Sam Robinson, Rodney Wong, Dame Fran Wilde, and Dame Diana Crossan.

- **Sponsorship:** Acknowledgement of sponsors and partners: ASB, Dentons, HSE Global, Brannigans, Intepeople, BDO Manawātū, PwC Hawke's Bay, and KPMG.
 - Recognition of sponsors' contributions beyond financial support, including: event hosting; active engagement with the committee and members; readiness to provide support and advice
